The Menard County Board of Commissioners met on Tuesday **November 10, 2020** at 6:00 p.m. in the Menard County Courthouse, 102 S. Seventh Street, Petersburg, Illinois. Commissioners Jeff Fore, Allan Anderson, Ed Whitcomb and Troy Cummings were physically present. A quorum was present. County Coordinator Dara Worthington, County Clerk Martha Gum, County Treasurer Pam Bauser, State's Attorney Gabe Grosboll, and Sheriff Mark Oller were also present. Commissioner Bob Lott was absent.

Acting Chairman Jeff Fore called the meeting to order at 6:00 p.m.

Commissioner Cummings moved to approve the consent agenda which included the minutes from the October 27, 2020 Regular Board Meeting, and Executive Session from the same date. Commissioner Whitcomb seconded the motion. The motion carried with four 'ayes', no 'nays', and one absent.

#### Scheduled/Unscheduled Guests

Dave Bagot, member of the Menard County Board of Health, was in attendance and discussed the COVID pandemic. He expressed the Board of Health's interest in mandating masks in public, having only small gatherings and having advertising campaigns. A lengthy discussion about pushback from county bars and restaurants followed. The Board of Health would like the support of the community leaders.

Sarah Yoder, Sunny Acres Administrator was in attendance via telephone and presented information on COVID19 activity at Sunny Acres. She informed the Board there are currently four positive residents and four positive staff. She presented a proposal for hazard pay which Heritage Operations is implementing and discussion ensued. She noted the hazard pay will be covered under the Cures Act reimbursement program. Commissioner Cummings moved to approve the hazard pay as presented. Commissioner Anderson seconded the motion. The motion carried with four 'ayes', no 'nays', and one absent.

### Highway Department Report/Requests for Board Action

County Highway Engineer Corey Dowd was in attendance and updated the Board on activity related to his Department. He discussed his proposed Fiscal Year 2021 budget, specifically discussing the Motor Fuel Tax fund.

State's Attorney Grosboll spoke with attorney's through UCCI regarding increasing rates for Highway Road Commissioners and Clerks. He discussed a couple different statutes

concerning increasing these rates. Mr. Grosboll is waiting to hear back from UCCI. Highway Engineer Dowd explained what the current rates are and shared his research on how other counties handle this.
