The public meeting was opened for comments and considerations for Case Number 22-2TA at 6:32pm.

Babe Hill represented herself to give an overview of her text amendment application. Babe currently has 79 acres at 20387 Gudgel Ave. She would like to use approximately 3 acres, once monthly during the warmer months to invite small vendors of many sorts, such as food, small business, live music, etc. from 10am- 3pm. Vendors only would be allowed to camp on her property for easily accessible set up. Other vendors will have the option to set up as early as 6am. Eventually, Babe would also like to interpret a produce and animal swap into the event. She would like to see this grow into a "blue grass festival", that holds educational value as well.

Neighbors Valerie Talyor and David Berry were present to seek clarification on the Text Amendment definition and voice their live music concerns.

One concern from the ZBA members had alcohol sales/insurance. In discussion, Babe changed course of action to hinder away from use of any alcohol on her property.

After discussion, Zoning Board of Appeals moved to Recommend the Text Amendment with stipulations to Board of Commissioners.
